Brokers submit necessary information & appropriate payments to CBP on behalf of their clients. Brokers must have expertise in the entry procedures, admissibility requirements, classification, valuation, & the rates of duty and applicable taxes.

The NCBFAA's Certified Customs Specialist (CCS) Certification Program is designed to assist trade professionals involved in the import industry to become experts in the current import regulations.

#### **Notary Public in and for the State of Ohio**

A notary public (or notary or public notary) in the common law world is a public officer constituted by law to serve the public in non-contentious matters usually concerned with estates, deeds, powers-of-attorney, and foreign and international business. A notary's main functions are to administer oaths and affirmations, take affidavits and statutory declarations, witness and authenticate the execution of certain classes of documents, take acknowledgments of deeds and other conveyances, etc.
